| Legal basis for processing your data         | <ul style="list-style-type: none"> <li>Performing the administration that it is necessary to operate the CCCL</li> <li>In all other cases: that it is necessary for our legitimate interests which are to regulate the sport of cricket within the CCCL and to ensure that the reputation of cricket is preserved and enhanced, and this does not prejudice or harm your rights and freedom</li> </ul> |
| Your right to withdraw consent               | <ul style="list-style-type: none"> <li>Where you have given your consent to any processing of personal data you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</li> </ul>  |
| How long we will keep your personal data for | <ul style="list-style-type: none"> <li>We will normally keep your personal data for 3 years after your last engagement with us</li> </ul>  |
| Your rights in respect of your personal data | <ul style="list-style-type: none"> <li>You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.</li> </ul>  |
